PURPOSE

The purpose of this agreement is to regulate the artificial movement of the Emerald Ash Borer. This compliance agreement establishes standards for the handling and movement of ash within an area regulated for Emerald Ash Borer.

On its own, the Emerald Ash Borer moves approximately one half of a mile per year. However, through artificial movement (firewood, timber, etc.), the Emerald Ash Borer can be moved many tens or hundreds of miles. This agreement is drafted to prevent the long distance movement of this pest.

AUTHORITY

Indiana Code: IC 14-24; Emerald Ash Borer emergency quarantine 312 IAC 18-3-18 and amendments.

REGULATED ARTICLES

Ash logs, ash stumps, ash branches, ash debris > 1 inch in diameter, and ash chips > 1 inch diameter to approved mills, landfills, or marshaling yards, outside the regulated area.

I/We hereby enter into a compliance agreement with the state of Indiana under the provisions of the Emerald Ash Borer Quarantine and agree to move regulated articles only as provided for on this compliance agreement. Regulated ash logs, lumber with bark, or bark, will be shipped only from a regulated area to a non-regulated area, or from an infested township to a quarantined county, only if the articles will move to a mill approved under an appropriate USDA and/or IDNR compliance agreement. All regulated ash articles must be shipped directly to an approved mill, landfill, or marshaling yard.

October 1 - March 31: Shipments of regulated ash articles will be allowed. A copy of this compliance agreement must be present with each shipment. Shipments must proceed from origin to destination without stopping (except for refueling or traffic conditions).

April 1 - September 30: No shipments of regulated ash articles.

A record will be maintained of all shipments of regulated articles moved under this compliance agreement. The records will contain dates, invoice numbers, truck identification, origin/shipper and destination. Mill, landfills, and marshaling yard destinations must be approved under a USDA and/or IDNR compliance agreement.

The state of Indiana retains the right to conduct inspections, monitor procedures, and examine regulated articles and records during regular business hours.

The state of Indiana has the right to revise or cancel this compliance agreement at anytime. In addition, failure to comply with the provisions may result in the assessment of fines and/or penalties.
