#### **APPLICATION INFORMATION AND PRECAUTIONS**

- Use of sufficient spray volume and pressure is essential to ensure complete coverage. Use a minimum of 15 gallons of spray solution per acre (gpa) with a minimum spray pressure of 40 pounds per square inch (psi) at the nozzle and a maximum ground speed of 10 mph.
- Do not use flood nozzles.
- Do not apply Select Max Herbicide if rain is expected within 1 hour of application; otherwise unsatisfactory weed control may result.
- Do not replant dent corn sooner than 5 days after application.
- Do not apply this product when weather conditions favor spray drift from treated areas.
- Do not graze treated fields or feed treated forage or hay to livestock.
- Care must be taken to avoid in field overlaps or excessive crop injury may occur
